Mr. Peter Teitelbaum, Mr. Fred Mannix, and Mr. Patrick Tropeano were present before the board on behalf of the Crossroads Apartments Senior Affordable Local Initiative Project.

Mr. Teitelbaum explained that Mr. Mannix previously had been granted approval for an assisted living development on the location at 242 Sandwich Road. Due to the changes in the way our society views 'elder care', the decision was made to change the proposed development to 60 units of Senior Affordable Housing. In conjunction with this change of plan Mr. Mannix has presented before the Zoning Board of Appeals, and had an updated traffic study completed. His permit has been extended for two years.

Mr. Teitelbaum explained that this proposal is a 'friendly' 40 B development, under the Local Initiative Project (LIP) It is the intent and desire of the developer to work with the Town to provide much needed housing for those over the age of 55. The project previously had a 'sewer set aside' from the WPCF and the Sewer Commissioners, so the project is not hindered by the 'moratorium. Mr. Mannix spoke briefly about his over 4 decades of working in the building industry, which has included working on dormitories for Berklee College, and a development of the Hotel Onyx (Boston).

Mr. Mannix has an appointment to meet with the commissioner of EOHLC (Executive Office of Housing and Livable Communities) to explore the

opportunities for support for such a project. The process of obtaining financing may be lengthy.
