SEWER BUSINESS

1. Article 5

The Board discussed Article 5, which was written by the Town Administrator, and how it utilizes the \$3 million appropriated for the work. A copy of Article 5 was not available to all commissioners prior to the meeting. The Board discussed how Article 5 would be a combination of Article 2 and Article 3. Article 3 proposed \$300,000 for engineering. The Board continued the discussion regarding Article 5. Commissioner Giberti motioned to submit Article 5 as newly written. Commissioner Scanlon Seconded. VOTE: 4-1-0

2. Article 1

Article 1 is regarding \$36 Million for the upgrades of the Clarifiers and Headworks Building at the WPCF. The Board discussed what payments would look like for the project as well as interest rates, and the discussion also included information regarding the current equipment's state. The Board voted 4-0-1 to submit Article 1. The discussion also included the vote for Article 2, being 5-0-0 to by-pass the article at town meeting. Article 3 is for \$300,000 in engineering costs.

3. Article 3

The Board quickly voted and discussed Article 3 due to the fact it was previously discussed when Article 5 was being explained. The Board vote 2-3-0 to accept the article. This failed. Vote 3-2-0 to by-pass article 3 at town meeting.

4. Article 4

The Board voted to pass over Article 4. VOTE: 5-0-0.

Vote 5-0-0 to transfer \$200k from fy 23 salary line to contractor line to cover ghd and weston & sampson expense.
