1. MEETING TO ORDER

Chairman Giberti called the meeting to order at 6:30 pm.

SEWER BUSINESS

1. Meeting Minutes

2. Staffing

Director Campinha explained the dire situation the WPCF is in due to such short staffing. Based on a chart made for Wastewater Treatment Plants, the WPCF's 12.04 CMR requires at least 18 staff members, the WPCF currently has five (5) employees to run the plant. Mr. Campinha is working with Human Resources regarding applications and job postings.

3. Moratorium

The Board touched on the Moratorium as well as looking at commitments that have not used their Gallonage and are beyond their allocation. (Please refer to the Jun 4, 2020, meeting for more information regarding the policy made for gallon allocation). The Board received a list of projects as well as the Gallonage requested for the projects. There are several versions of this list – we need to create one standard one.

- 5. Ferreria letter and invoice for the cancelled swift beach project has been sent to the town attorney for review.

6.. Marine Biological Lab- Woodchip Effluent

Ken Foreman, a Researcher at the Marine Biological Lab discussed the pilot study done at the WPCF to look at the ability to use woodchips to help denitrify the wastewater effluent, to help improve the water quality. The executive summary of the research was presented to the Board members to review. Mr. Foreman went into depth on how the woodchips will help with the denitrification process and improve the water quality of the effluent. He also discussed the bacterial aspect of the report, and how the bacteria will also play a role in the process. The discussion continued for a while. The Board voted 5-0-0 to go after a grant for the woodchip project.

2. Greasezilla

The Board went over an earlier presentation for Greasezilla and the project will not cost the WPCF anything. The Board voted 5-0-0 to allow the pilot program for the Greasezilla to move forward.

3. Contracts

The Board voted 5-0-0 to accept the South Shore Generator contract for \$14,500.00. The contract is for three years.

Confirmed vote 5-0-0 for 3 yr contract with synagro – sludge disposal.

4. SEWER SUPERINTENDENT'S REPORT

- Mr. Campinha spoke briefly on Woodland Cove and the buildings that are getting ready to connect to the Force Main. He spoke about the grinder Pumps going in, and the non-flushables that cause damage to the pumps will not be the responsibility of the WPCF to replace.
- Hamilton Beach residents are meeting and addressing the root issue in the community. The WPCF has free Root-X for all sewer users at the plant (6 Tony's Lane Wareham, MA 02571 in the Main Office Building). The WPCF also scheduled a Root-X demo for July 17th for the Employees to see other possibilities of products. Mr. Campinha spoke on the Grease-X the company carries and the benefits it could have for the sewer lines.
- Mr. Campinha spoke on the elementary school emails that were coming into the WPCF regarding the school pump station. Information regarding non-flushable items as well as the major effects it produces in the sewer system and for the sewer system, as well as the harm it can cause to the environment in an event of an overflow.

Three Blowers at the WPCF have failed, and it is around \$10,000 a piece for new blowers, and they are a vital piece of equipment for the WPCF top function.

5. UNFINISHED BUSINESS AND GENERAL ORDERS (Unanticipated Items)

A. Article 5 and the full amount for the project was discussed as well as what the money for the project will be for as well as the impact the money could have on the plant and its treatment.
