## 7. NEW BUSINESS

a) Discussion regarding Sump Pumps (including requirements)

Brief discussion about the illegality of sump pumps being tied into the sewer system. Additional information needed from the Mr. Campinha as to where there is sump pumps connected to the sewer system. Board agrees to research what other communities may be doing to address this problem. Commissioner Dunlop raised the question if the water drained from a home can be drained into the street and into a storm drain.

Board agreed that the Chairman would meet with the Town Administrator to coordinate a meeting with all parties (Selectmen, Town Administrator, Sewer Commissioners, Town Counsel and the Assads). Chairman Giberti to contact the Assads regarding when such meeting can be arranged.

- d) Meeting with Onset Water Commissioners at Onset Water Dept March 8, 2017 Chairman Giberti announced that the meeting with the Onset Water Commissioners on March 8, 2017 would be at 6:30 pm on Wednesday, March 8, 2017.
- e) Discussion reimbursements for tuition and books for courses taken relative to WPCF Chairman Giberti suggested that the Sewer Commissioners be reimbursed for courses and books taken by them relative to sewer matters. The Board agreed.
