	Mr. Brad Bertollo of J.C. Engineering approached the Board with the	

following variance:

- 1. A 3.4' variance (10.0'-6.6') for the setback from the leaching facility to the side property line of Lot 400 (27 Peaceful Lane).
- 2. A 2.5' variance (10.0'-7.5') for the setback from the leaching facility to the rear property line of Line 421 through 425 (18 Mayflower Lane).
- 3. A 9.5' variance (20.0'-10.5') for the setback from the leaching facility to the foundation wall.

On a motion of Frank DeFelice, the setbacks were approved as stated on the plan with the requirement a deed restriction is filed at the Registry of Deeds limiting the home to two bedrooms. All Members voted in favor. All variances granted with deed restriction.

New Business- Maria Christos of 197 Marion Road, appeared before the Board to appeal a late fee for not registering rental property. Ms. Christos stated they did not receive a notice in the mail and feel the fine is high priced. After lengthy discussion the Board agreed to waive the fine. The Board will put rental fees/fines on the agenda for future discussion.

5:20 p.m. Robert Perry, Esq., Tobacco License Request

Mr. Robert Perry, Esq. appeared before the Board to request a tobacco permit for his client who had been denied by the Board of Health. According to Board of Health regulations, as of January 2013 the maximum number of Tobacco and Nicotine Delivery Product Sales Permits, at any given time, states there shall be no more than forty (40) issued in the Town of Wareham. Attorney Perry requested the Board look into a change of regulations. Dr. Wiegandt stated there would not be a change since the tobacco regulations were just recently reviewed. Dr. Wiegandt suggested the office review the list of tobacco permits in Wareham as establishments may have closed. Attorney Perry will contact the office.

5:40 p.m. G.A.F. Engineering- 5 Wildrose Avenue- Variance to Local Regs.

Mr. Brian Grady of G.A.F. Engineering approached the Board with the following local & State variance requests to Wareham Board of Health regulations.

Local

- 1. Required: Sewage disposal systems for new single family dwellings shall be designed for one more bedroom than will actually exist.
- 2. Provided: The existing dwelling on the lot has three (3) bedrooms. The system is designed for three (3) bedrooms.

310 CMR

- 1. Top of all system components shall be no more than 36 inches below finished grade.
- 2. Provided: Leaching field is proposed to be approximately 34" to 50" below finished grade.

Mrs. Phinney made a motion to close the meeting at 6:20 p.m. All in favor.
