She stated that the small kids come in and they love getting books. Halloween Fun day they had approximately 200-300 people walk through the doors.

Selectman Whiteside read a report on the Public Way's Project "as attached". After some discussion Selectman Whiteside asked for another week to go over this project with Town Counsel.

The Mass DOT will be holding a public hearing on Thursday, December 10, 2015 at the Transportation Library in Boston at 2:00 p.m. The agenda includes an application by Clear Channel Outdoor for one permit to replace existing traditional billboard permits at 3077 Cranberry Highway.

The Street light work should start on Monday.
