4. SEWER BUSINESS

a) Presentation of Mitigation Report regarding Bay Pointe Mixed use Development Project

Mr. Furtado provided an explanation of the testing performed on the Bay Pointe existing sewer pump station. Mr. Principe further explained the mitigation reports for the pump stations (private and Town owned).
