

### CONTRACTOR QUESTIONS THIS DOCUMENT IS NOT PART OF THE ADDENDUM

The following is a summary of the proposed work discussed at the mandatory Pre-Bid Meeting on March 3, 2021 at the Narrows Pump Station site. This is <u>NOT</u> part of the addendum. This is for informational purposes only.

- 1. Existing force main is a 16-inch force main and there are no other known force mains connected to this force main.
- 2. Groundwater is expected to be 3 to 4 feet below grade and dewatering is to be expected.
- 3. Filter bag is to be used for dewatering and discharge is to be sent to the catch basin to the west of the pump station.
- 4. No stockpiled material is to be left overnight.
- 5. Test run with septage trucks is to be completed at night.
- 6. Town to pay for the septage trucks, but the Contractor is responsible for coordinating the septage trucks.
- 7. Per the plans the 6-inch cam-lock quick connect is to be located in the pavement and the flange for the pig launch will be installed above grade within the pump station site.
- 8. Town is to operate the pump station and all valves necessary during construction.

The following are questions received from the contractors at or prior to the mandatory Pre-Bid Meeting on March 3, 2021 at the Narrows Pump Station site. This is <u>NOT</u> part of the addendum. This is for informational purposes only. Please note that some questions are paraphrased.

1) Does the project need to comply with American Iron and Steel requirements?

GHD Response: The project does not have American Iron and Steel requirements, please see Addendum No. 1.

2) <u>Is the 6-inch pipe connecting to the existing sewer manhole to be installed at the same elevation as the existing pipes in the manhole?</u>

GHD Response: Yes, the elevation is to match the elevation of the outlet pipe going to the wet well. This can be adjusted in the field, with Engineer approval, as necessary depending on the elevation of the existing force main.
