This is a follow up to my November 8, 2021 request for public records that has not been responded to. A copy of the request accompanies this letter.

In accordance with your request for public records process, this is a request under the Massachusetts Public Records Law (G.L. c. 66, § 10). I am requesting that I be provided a copy of the following records:

- 1. All communications to or from members of the Wareham Board of Appeals or its agents to the Onset Water District or its employees or agents regarding the project permitted under G.L. c. 40B located off of Red Brook Road more commonly known as "Settler's Glen" (hereinafter the "Project");
- 2. All written correspondence to or from members of the Wareham Board of Appeals or its agents to the Onset Water District or its employees or agents regarding the Project;
- 3. Copies of all emails regarding the Project and the application for a water connection and/or water services for the Project to and from any past or current water superintendent;
- 4. Copies of the recordings of the Prudential Committee for its meetings beginning on October 12, 2021 through November 11, 2021. Demand is made that all recordings be preserved and provided;
- 5. Copies of all meeting minutes of the of the Prudential Committee for its meetings beginning on October 12, 2021 through November 11, 2021;
- 6. Copies of all text messages to or from members of the Prudential Committee and its employees or agents regarding the Project or the application for a water connection or services for the Project; and
- 7. Any email communication between the members of the Prudential Committee and its employees or agents regarding the Project or the application for a water connection or services for the Project.

The Public Records Law requires that you provide me with a written response within 10 calendar days. It also requires that records be produced electronically in a searchable format. If the records cannot be produced electronically, I recognize that you may charge reasonable costs for copies, as well as for personnel time in excess of four hours, needed to comply with this request. If you expect costs to exceed \$10.00, please provide a detailed fee estimate. If you cannot comply with my request, kindly provide an explanation in writing, as required by the statute.

GUIDELINE TO REQUESTING PUBLIC RECORDS

Steps to requesting public records from the Onset Fire District:

- 1. Submit a written request on the form provided by the Onset Fire District or email your request to onsetadmin@comcast.net
- 2. Make sure your request is complete with as much information as possible.
- 3. The Onset Fire District tries to fill all public records requests free of charge. However, if the request is extensive, there will be a fee of \$0.05 per copy and an hourly rate of \$25.00 for research if required. All charges will be disclosed, and payment is required, prior to any work being started.
- 4. The Onset Fire District will respond to all requests within 10 business days.

A Brief History of the Onset Fire District:

In 1890 the Ladies Industrial Union formed a private Fire Company in Onset called the Industry Hook and Ladder. The Industry Hook and Ladder Fire Company became the Onset Fire Department in 1894 and was approved by the Legislature in 1895.

In 1892 the Onset Water Comany was formed as a private enterprise.
