

We are writing you as concerned citizens, indeed as concerned human beings, regarding the recent developments concerning the property occupied by Kendra Bond and Peace for All Animal located at 12 Great Neck Road, Fast Wareham, MA.

It has recently been brought to our attention that Kendra, and the selfless work she has done for over a decade through Peace for All Animals, is at risk of losing its ability to house, care for and rehabilitate animals that have been neglected, abused and at times even selected for systematic extermination.

We have only recently come to know Kendra and the important work that she does. And what we have realized in a very short time is that although on the surface it would appear that her work only saves the lives of deserving animals, a deeper look reveals significantly more than that.

We could argue to you that her work is important because it saves mothers and offspring from needless killings. We could advocate that the animals she saves deserve the same chance at life that we are afforded. We could try to justify her work by saving that no just God has plans for random killing, and that the animals she saves are often subjected to exactly that. They are frequently starved and neglected until they simply die and can be harvested for their hides. Those would be the easy reasons to argue for Kendra and her organization.

We have land and chickens and goats. They are all animals we have acquired purely for the enjoyment of providing them with a good life and for enhancing the enjoyment of our own lives by being able to interact with them every day. We have been anything but disappointed in our efforts.

Recently my wife and I had the opportunity to spend some time at Kendra's place as we considered adding donkeys to our little farm in Carver, Massachusetts. During our first visit we were drawn in by how clean and well kept her little farm was. The paddocks and the barns were spotless. There was no offensive smell. All water containers were full to their brims. Clearly the animals there were well cared for. Clearly Peace for All Animals respected it's neighbors as demonstrated by how clean and well kept the area was. As we spent some time visiting with the two donkeys we would eventually agree to adopt, no less than three volunteers came and went, cleaning paddocks, cutting fresh produce, feeding and interacting with all of the animals at the facility.

We had the opportunity to talk with each of them. Collectively there was over 20 years of Peace for All Animals volunteer experience between them. And each spoke at length of the positive experiences that had working both with Kendra as well as the animals there. This was our first indication that Peace for Animals wasn't simply a place that brought peace to animals...

We returned to 12 Great Neck Road one evening about 10 days later. We went simply to spend some time with the two boys we had agreed to adopt. It was dark and once again, we entered a spotless barn with full water containers, plenty of soft bedding and with stalls that allowed the two brothers to interact with each other but not get close enough to hurt each other. You see, both had been orphaned

at only a few months old when their mothers were plucked from kill pens and sacrificed for their hides, leaving the two little ones with no idea how to socially interact with their own kind.

As we settled in to spend some time with them another volunteer entered the barn. She was a young woman, likely in her late 30's or early 40's. Although her name escapes me, her story does not. She told us she had been volunteering at Kendra's place for about five years. Initially she was inspired to participate based on an urge to do something good for someone or something less fortunate. But recently she had gone through some very difficult personal trials and in the last year she had come to Kendra's place not to heal, but to be healed.

She came every Wednesday night, and she brought fresh parsley. She said it was the best five dollars she spent every week. She would simply go from barn to barn feeding it to the donkeys and talking, telling them of her struggles, telling them of her pain. She said they never judged. They never offered advice to solve her problems. They never blamed or accused. And what she realized over time was that she hurt less. She realized that she was healing. So now she still came every Wednesday night... to talk... to say thank you. To repay the debt she felt she owed the animals who otherwise would have been killed because they were considered to be worth no more than their pelts.

It was in this moment that we realized that the amazing work Kendra does through Peace for All Animals was not just for the animals it saved. It was for all of us. It was for me, for you, for your sister or your mother. It was for anyone who needed to feel cared about, for anyone who needed to not feel judged or labelled, for anyone who needed to be loved.

I would not consider my wife and I to be eccentrics. We both work in the medical field, a field driven by research and science, a field that operates based on tangible input and outcomes. We have spent a combined 50 years saving people. What we experienced that night at Kendra's place affected us deeply. We realized that in saving those animals, Kendra's work saves people.

We hope you will consider this in making your determination regarding Peace for Animals and their ability to save the countless creatures, and species, they do every day.


