Decision/Reason:

The Petitioner was before the Zoning Board of Appeals on September 13, 2023, pursuant to a Notice of Violation dated July 11, 2023, issued by the Building Commissioner who determined that the Petitioner was in violation of the Special Permit granted to this property June 5, 2017 by the Planning Board. More specifically he stated that the landowner was in violation of condition #21, which stated "No outside storage of materials and equipment shall be allowed". Accordingly, the Petitioner brought the appeal to the Board of Appeals who granted the Minor Modification of the Special Permit.

The Board of Appeals first looked at the request to vote on whether this was a Major or Minor Modification of the Special Permit 2017. After hearing testimony from Petitioners counsel, and their direct abutters, the Board found that this would be a Minor Modification as it is not changing any of the dimensions of the project or creating any new nonconformities or hazards. After voting 5-0-0 on the Minor, they agreed that Minor Modification should be allowed as several other businesses in the area have equipment yards in this area. They found that allowing materials and equipment behind the building in the yard was not detrimental to the neighborhood.

This hereby vacates the Notice of Violation previously issued by the Building Commissioner, as the site may now be in compliance with the modified Conditions of the Special Permit.

Further, the granting of this Minor Modification:

Conditions:

- 1. The Owner will put up screening on the fence and gate at the front of the building
- 2. There shall be no equipment or materials outside of the front of the building. Equipment and materials shall be stored in the back fenced in yard.
- 3. All other non-modified conditions of the decision shall remain in force.
