Annual Report of the Community PreservationCommittee July 1, 2021 – June 30, 2022 To the Honorable Board of Selectman, Town Administrator and the Citizens of Wareham

THE COMMUNITY PRESERVATION ACT, MGL CHAPTER 44B (CPA), IS LEGISLATION WHICH ALLOWS CITIES AND TOWNS IN THE COMMONWEALTH OF MASSACHUSETTS TO ADOPT A PROPERTY TAX SURCHARGE WITH SURCHARGE REVENUES PLUS MATCHING FUNDS FROM THE STATE TO BE ALLOCATED FOR THE "ACQUISITION, CREATION AND PRESERVATION OF OPEN SPACE, THE ACQUISITION, CREATION AND PRESERVATION OF HISTORIC STRUCTURES AND LANDSCAPES AND THE CREATION AND PRESERVATION OF COMMUNITY HOUSING."<sup>1</sup>

In 2002, Wareham enacted the Community Preservation Act (CPA) approving a 3% real estate tax surcharge (with initial \$100,000 property value exclusion) which qualifies the Town to receive state funds from the Commonwealth each year. The state funds are generated by recording fees at the Registrar of Deeds. To date the Town of Wareham has received \$6,117,535. of these funds.

In FY22, the Town of Wareham collected \$988,426 in CPA funds and received \$529,596 from the state. With funds unspent from prior year, Community Preservation Commission (CPC) had a starting balance of \$5,556,307. to support approved projects.
