Firms interested in bidding on the construction of the WPCF Improvements – Phase 2 project are invited to submit a Statement of Qualifications (SOQ) to the Town of Wareham. This Request for Qualifications (RFQ) procurement is conducted pursuant to M.G.L. Chapter 149, Section 44 D1/2 and 44 D3/4. This RFQ is the first phase of a two-phase procurement process as set forth in M.G.L. Chapter 149. A Prequalification Committee has been established, will prequalify firms interested in bidding through this RFQ process, and select those respondents it deems qualified. Only those respondents deemed qualified will be invited to bid. A detailed set of plans and specifications will then be issued in the second phase of the procurement process. The Town expects the bidding to be initiated on or about February 26, 2024.

The project involves renovations and improvements to an existing 1.56 MGD water pollution control facility located at 6 Tony's Lane, Wareham, MA. This project includes upgrades to the Headworks Building and addition of new Secondary Clarifiers. Ancillary equipment replacement and process upgrades will be performed including headworks equipment, sludge pumping, dewatering odor control system, architectural renovations to existing Headworks Building, and construction of new Alkalinity Building and Vehicle Storage Building. The project will be subject to the minimum wage rates set under the Massachusetts Prevailing Wage Laws and Davis Bacon Wage Laws.

It is anticipated that the contract will be awarded by June 30, 2024.

Interested firms must submit an SOQ by the deadline set for submission. Only those firms determined to be qualified by the Prequalification Committee will be invited and permitted to submit a bid on the project. Firms that are not selected as qualified by the Prequalification Committee and firms that do not participate in the RFQ phase will be precluded from bidding on the project.

All further required public notice information regarding the Project, including the prequalification evaluation criteria and the selection process, is included in the RFQ available as outlined above.
