Does the town anticipate the \$200,000 fund allocation will cover all phases of the project (pre-25% through to construction support) or will additional funds be available to supplement the effort?

The town has appropriated \$200,000 of Community Preservation Act funds towards design of this project. The expectation is that this will cover the cost for all design services for this section of the Wareham Bikepath. If State and/or federal money is made available for other design and construction services, the Town will be adding those funds, as needed, to the cost of design and construction services.

Although you are requiring 10 single-sided pages, is this mainly to clarify the page count? Can they actually be printed out double-sided (i.e. 5 sheets of paper), to save paper?

Yes. Please save paper.

Does the Town or MassDOT have survey for any part of the project area available to the designer?

The Town has a 1948 layout plan and is researching survey information. Results will be provided to winning proposal. Wetlands will be flagged by the town.

Will the Town provide personal protective equipment and police detail for the public on the site visit?

Safety of the public is a priority and necessary measures will be taken during any public site visit.

If the CPA fund allocation of \$200,000 is the amount allocated for survey, design, and construction oversight, this seems to be quite low. Can the Town increase the design budget so this project can be designed and executed well?

The town has appropriated \$200,000 of Community Preservation Act funds towards design of this project. The expectation is that this will cover the cost for design services for all design services for this section of the Wareham Bikepath. If State and/or federal money is made available for other design and construction services, the Town will be adding those funds to the cost of construction services.

The price proposal does not count towards the 10 page limit.

Can you clarify what permits and engineering should be included within the proposal?

Permits include local permissions from Conservation Commission and public safety. Engineering needed for design and construction of a bike path follows MassDOT design steps, which is why the form for the cost estimate is the MassDOT form. "Design" means the preparation of full plans and specifications needed to publicly bid the project as a Massachusetts public works contract.

How was the project cost estimate generated?

The most recent cost estimates were provided in the TIP at \$5.22 million [MassDOT Project 607825].
