In the case of a multi-family development, the fee is <u>\$300.00</u> plus an additional <u>\$50.00</u> for every unit over two (2). Please make check payable to the Town of Wareham.

\*\*A check to cover two (2) legal advertisements for the public hearing should be made payable to <u>Wareham Week in the amount of \$100.00</u>.

\*\*The applicant will also be responsible for the costs of sending out abutter notifications by Certified Mail. The cost is \$6.90 per certified letter to each abutter. Please see Zoning Board secretary for cost of mailings. Please make check payable to the Town of Wareham.
