Section 11370 – Positive Displacement Blowers

A. Paragraph 1.01 – Description of Work: **DELETE** item A. in its entirety and **REPLACE** with the following:

- A. Furnish and test the following positive displacement blowers complete with sound attenuating enclosures, motors, drives, and all necessary accessories and appurtenances and in compliance with these specifications and as shown on the Drawings.
 1. Two (2) Rotary Positive Displacement Blowers (B-431, B-432). The blowers shall operate in a lead / lag / standby configuration.
- B. The positive displacement blowers shall be furnished consisting of the following:
 1. Design and Performance requirements as described herein.
 2. Products as described herein.
 3. System controls as described herein.
 4. Spare parts.

5. Transportation from the factory to job site.
6. Services of the Manufacturer's representative per Section 01640 – services by cloth media filtration system supplier and chemical feed pump supplier.
7. Shop drawings and operation and maintenance manuals per Section 01300.
8. Accessories described herein.
9. Process performance guarantee.

- A. This section covers the requirements for variable frequency drives (VFDs) to be provided for positive displacement blowers (B-431, B-432). The Rotary Positive Displacement Blower Manufacturer as defined in Section 11370 shall furnish the VFDs specified herein. The provider of the VFDs shall also provide all harmonic reduction equipment and other appurtenances required by this specification. Provide the hereinafter specified equipment as part of the systems called for in the Specifications and the Contract Drawings.
