#### c. Goals for Committee

Each attendee offered their ideas for the Goals of the Committee:

- Provide a by-law that addresses the needs of all stakeholders.
   Balance the competing interests of residents, developers, and landowners.
- Prepare the by-law so that it provides clear guidance to permit granting authorities and zoning enforcement officials, landowners, and residence. Remove ambiguities.
- Make sure that by-law clearly addresses environmental impacts and requires each project to meet those requirements.
- Add a performance condition to site plans and other applications that addresses "mining", sand and gravel removal as well as other changes to the site (eg. grading).
- Provide clear direction to reduce contentiousness on application reviews.
- Create incentives to position solar arrays in favorable locations (parking lots, roof tops, brown fields); minimize cutting of trees.
- Create a by-law that can adapt to new and changing technologies.
- Inform the Master Plan such that it addresses the community vision for Solar.
- Develop a communications plan to generate community support such that the by-laws are understood by the residents and are passed at Town Meeting. Ensure that constraints and trade-offs are communicated.
- Consider consolidating permit granting authorities currently duties are split between the Zoning and Planning Boards.
- Incorporate new Massachusetts Climate change law.
- Establish balance between growth, protecting the environment, and revenue for the town.
- Identify opportunities to incentivize placing solar in preferred places.
- Address accessory facilities and battery storage on solar sites.
- Create a by-law that works for small farms.
- Consider impacts of alternative renewable energy sources.

### **d.** Presentation by Staff

Mr. Buckland reviewed a presentation of relevant information and laws that will inform how we craft the by-law.

### e. Discussion and questions on the by-law

During the review of the background material Mr. Buckland noted that there is a possibility that the Attorney General may not approve the by-law passed by the Town in July. There was a lot of discussion about the impact of that by-law being rejected and ways to mitigate that impact.

Mr. Sullivan noted that the Town has currently met its net-metering quota and will suffer negative impact if solar is added to Town properties unless an alternative buyer for that power can be obtained.

The Committee discussed "expanding" the scope of the charter to encompass all forms of renewable energy (Wind, Water, etc). It was felt that the addressing the existing scope within the time allowed was significant and that expanding beyond would create a risk to meeting the objective.
